


Club Activities

Tippet earned his Tracking Dog title on November 13 at Champoeg State Park, Oregon, sponsored by Portland Dog Training Club. Fifty percent of entered dogs passed on a l ovely fall day, preceded by days of rain.

To earn this title, Tippet had to follow a track, aged 30-60 minutes, (track layers meet with judge the previous day and learn what track a judge wants on a particular piece of land). Track is 440-500yds long, has 3-5 turns, three must be 90 degree turns. There is a sock or cotton glove at the start, and leather glove at the end. The dog indicates the final glove and our presentation to the judge determines pass or fail. Tippet was solid throughout, working methodically and pulling his mom/handler well, making his turns confidently and accurately

Minutes of the Lost Coast Kennel Club November 15, 2016, at the Adorni Center, Eureka

BOARD MEETING: Called to order by President Beverly Morgan Lewis at 6:30 p.m.

Present: Sara Borok, Susan Dean, Beverly Morgan Lewis, Jill Otto, Kris and Bayard Smith, Cathy Wright.

Minutes of the Last Board Meeting: Approved as published.

<u>Report of the Treasurer:</u> Susan reported that there has been no new activity. The mailbox needs to be checked more often (No mail tonight because it was overfull and the office was closed at pick up), so Jill will check before the meetings and Kris will check half-way between meetings.

Unfinished Business:

- Informal Presentations: We will get back to the canine CPR person after the first of the year.

Minutes of the last meeting: Approved with the following correction: Add Friday to agility trial days.

Report of the President:

- Beverly thanked the members and the Board, especially Jill, for their support during her presidency. She said we know how to "play nice in the sandbox". Beverly was thanked for her service. Outgoing Board member Deb St Myers was thanked for her service on the Board.

<u>Report of the Secretary:</u> No mail today because box was too full and the office was closed. That will be brought up directly to the staff when doing the contract.

<u>Report of the Treasurer:</u> Nothing new. Membership renewals are coming in. Cathy will get a rubber stamp or return address labels. <u>Report of the Committees:</u>

Practice: Informal nose work and obedience practices have been organized by Cathy via the Yahoo Group. We will need someone to help this spring with our club practices because Kris will be out of town much of the time.

Newsletter, Website: No update.

Membership: No update.

B-OB Show

- Cathy reports: The last obedience judge has been found (Jill Jones). There will be 12 judges, 4 have less than 10 breeds. We need to get the committee started: Lined up Grounds (Nick), Trophies (Deb St Myers), Advertising (Deb Tull), Obedience (Sara Borok), Safety (Jill), FSS (Jill), Vendors (Tina). NEED JUDGES LIAISON (someone to arrange hotels and transportation from and to the Holiday Inn, Fortuna), RAFFLE, RALLY, HOSPITALITY.
- Additional events: Puppy 4-6 months on Friday, NOHS on Saturday, FSS Open Show on Friday and Saturday. Also, Peewee (6 8 year old handler, limited to 10, approved judge, \$5, Cathy will sponsor trophies medallions.)
- Fun Runs Kris will contact the Burchetts to see if they can commit to coming. We will see how the show does financially, then maybe ask for a share of the proceeds next year.
- Cathy went over the list of judges. Some judges are lined up for next year. We should have all of them lined up for 2018 soon. Discussion of what to do if a judge refuses to fill out a 1099 tax form.
- FSS (Foundation Stock Service) Open Show Jill: Premium list can be with the regular show, will need ribbons, maybe from MB-F. Entry fee should be lower. They do groups, then BIS among Misc and FS, so we need more trophies. Outreach to FSS Facebook page, and to Juniors. Jill checked to see if it was OK for her to show in FSS if she is the chair.
- We will see if Doris Boyd will do a handling class.

Agility Trial

Beverly has talked to Lori about the changes needed due to the new schedule.

July Barn Hunt: Clinic on Friday, double hunt on Saturday and Sunday. January Obedience Trials and Barn Hunt:

- Sara passed around the first draft of the premium. Deb St Myers will order 100 more toys for trophies. Vendors will be Humboldt Pet or Arcata Pet, Deb Tull, maybe Kimber's massage. Food vendor "Uniquely Yours" will be asked to have items under \$6.
