## From Kris Smith:

### A CAUTIONARY TALE

I want to share with you a description of an ongoing health issue with our almost 3 year old Neida, in hopes it will help others with diagnosis. Back in October, she began moving stiffly, as if she were sore over her loins. She has had some recurring stiffness in her hips, so we assumed this was a worsening of a current problem, and just put her "on the bench" with rest and limited exercise. She got worse; the chiropractor found some spots to adjust, but felt she was treating symptoms which were secondary to something more serious. She lost her appetite, dropped weight quickly, and was fading before our eyes. An anti inflammatory helped for a few days, but she kept deteriorating. Stuck on the idea that it was musculoskeletal, we had radiographs done of her spine and hips, all in great shape. We did blood work, which showed high liver and white counts.

She came off the anti inflammatory because of the liver values, and was started on liver support supplements. Still she got worse, hardly able to move, like a creeping paralysis. We scheduled an abdominal ultrasound to check the liver – all the organs looked fine. More blood work showed liver values still going up. Then, while our vet, who is also our daughter, was in the clinic late on emergency, she brainstormed with her tech, and they decided to test the blood they still had for tick borne diseases. There it was – anaplasma, which is a tick borne bacteria, carried by the same ticks that carry Lyme. She was on doxycycline by 11 pm, and was already starting to feel better by the next morning.

Since then she has improved a little every day, but not without worry. Blood work a week later showed liver values still high, possibly from the doxy. We are trying to balance enough antibiotic to kill the bacteria without damaging her liver, and it's an ongoing struggle.

I know there are ticks and fleas in this general area, but I had not seen any last fall. I lengthened the time between preventative treatments because I didn't think the dogs were getting exposed. I don't know if she picked up a tiny tick here, or when we were traveling, but I never saw it, and never saw her scratching like they do when they have one.

I have two takeaways from this experience. First, stay up to date on your flea/tick prevention, what ever you use. Second, if you are dealing with mysterious symptoms which are not responding or don't make sense, don't be shy about asking for a test for tick borne diseases. I wish we had thought of it months ago.

Minutes of the Last Meeting: MSAC to approve as corrected (change "Sally" to "Sandy").

Report of the Treasurer: Patty - Discussion of signatories for the checking account – will take Jill off of the list, but she will have a checkbook, as she is centrally located. Will report with "Profit and Loss" statements; way to keep track of how things are going. Discussion of what has been paid for, on which account. Minutes of the Last Meeting: MSAC to approve as published.

Report of the (Vice) President: The Rally Clinic was well attended and very good; everybody learned a lot.

Report of the Secretary: Mail: Various catalogs and promotional material.

<u>Report of the Treasurer:</u> Patty has been through the records of previous treasurers. The computer is old, and there is no way to reconcile. She has opened a new account at Redwood Capital Bank. People who can sign checks are Linda (President), Patty (Treasurer), Cathy (Show Chair), Beverly (Agility Chair). Patty and Jill will have checkbooks.

### Report of Committees:

- <u>Practice</u>: Cathy has been encouraging people to practice and enter our Scent Work trials. There have been about one per month at Ridgewood School. Next will be December 9 and 30. Discussion of what to bring to SW practice.
- Newsletter: Great newsletter! Lots of good items and photos, some gleaned from Facebook.
- Website: Updated.
- Yahoo Group: People who are not in it can request via lostcoastkc@gmail.com.
- Membership: Updated list is in the files on the Yahoo Group.
- Event Team: Cathy reported that there will be two meetings coming up, December 9 and 30. Notes from the meetings are in the newsletter. She distributed a chart with jobs and events, which will show what we need, and encourage people to learn how to do things. Anybody can add information.
- <u>January Rally/Obedience Trials</u>: January (19), 20, 21. Judges' contracts are in, premium list is finished, trophy sponsors coming in, hotel arranged (Red Lion), ribbons and pins will be ordered. Will need Hum DOG's mats, trailer should be there Thursday afternoon. Hot dog vendor will be there. Trial Secretary will mail or email premium list to previous competitors. Popular judges should help entries. Set up at 9 a.m. Friday. Pat announced that HumDOG will offer rally and obedience practice at Redwood Acres on January 8 and 15 at 5 and 8 p.m., on a drop-in basis.
- Scent Work Trials: February (2), 3, 4. There will be a Sniff and Go on Friday before the Obedience/Rally trials, from 2 to 4 p.m. on Friday. The premium list is out for the SW trials, and a flier which can be taken to other events. Advanced dogs can enter on the day of the trial (Sunday). Lots of new people are coming to practice. Ribbons will be ordered. Will have a raffle of SW items. People are being encouraged to come to watch, but leave unentered dogs at home. Other clubs seem to be breaking even on their events.
- <u>B-OB Shows</u>: Cathy is nearly ready to put in the application. Kathy Britton is in contact with the judges. Contracts have been written up as per dog rather than a fee, which is a change that needs to be approved by the Board. Details are being handled at the Event Team meetings. Beverly Chang is helping with sponsors and trophies. We need a Judges Hospitality/liaison volunteer. Prefer Red Lion because of the airport shuttle.

• <u>Agility Trial and Barn Hunt</u>: Nothing new from Agility Chair Beverly.

Barn Hunt: Cathy brought up a discussion of the hired helpers. They should be people who are physically fit so they won't injure themselves moving bales.

Election of New Members: no new applications

Election of Officers and Board Members: No nominations were received in addition to the slate presented by the Nominating Committee. MSAC to approve the following officers and board members by acclamation. President: Linda Bergstrom. Vice President, Jill Otto. Secretary, Kris Smith. Treasurer, Patty Mendes. Board Members: Sara Borok, Debbie Tull, Cathy Wright. Jill Otto was thanked for filling three positions at times throughout the year.

#### Unfinished Business:

- Rally Clinic: The Rally clinic presented by Sandy Svenson was well received and attended. All participants learned something. And, it made a profit! We would probably do it again.
- Donations: The Treasurer is still working on putting our financial situation in order. Dogwood Animal Rescue Project, Santa Rosa, was suggested as a recipient of a donation for fire victims.
