Puck earned his MACH 4 at the Lost Coast Kennel Club trial, 7/20/2014!



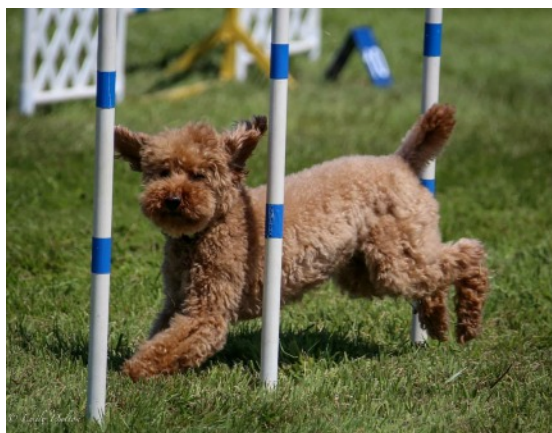
No one was as surprised as I when Druid went overall High in Trial at our HumDOG CPE agility trial this last weekend. I can't tell you how proud I am of this little man!!

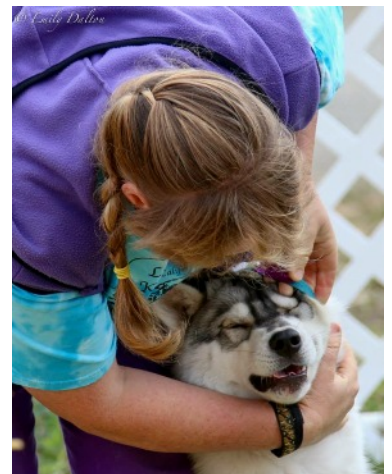
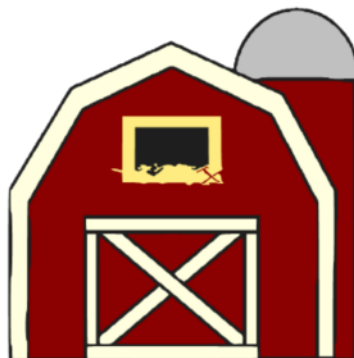

MINUTES OF THE LOST COAST KENNEL CLUB

July 15, 2014, Adorni Center, Eureka

BOARD MEETING: Called to order by President Beverly Morgan Lewis at 6:34 p.m.

Present: Sara Borok, Emily Dalton, Sandra Gould, Beverly Morgan Lewis, Jill Otto, Kris Smith, Deb St Myers.

Minutes of the Last Meeting: MSAC to accept as published.

Report of the Treasurer: Sandra distributed and explained a Treasurer's Report for June and a preliminary report on the show. According to the report, income will be about \$7500, significantly higher than previous years. Costs were cut in many areas, raffle made more.

Unfinished business: August 19 HumCo Fair dog event: Sandra will be gone; Sara will be in charge. "Things to do with dogs outside." Some equipment from different activities like agility, drive ball, barn hunt, etc. Plans can progress better after agility trials.

New Business: Emily reported that, via AKC, two show competitors were not eligible and need to return any prizes they won (did not have individual registrations).

The Board meeting was adjourned at 7:00 p.m.

REGULAR MEETING: Called to order by President Beverly Morgan Lewis at 7:01 p.m.

Present: All of the above plus: Rose Kessler, Josephine Morrissey, Tina Moulton, and guest Kathy Sobilo.

Minutes of the Last Meeting: MSAC to accept as published.

Report of the President: Big thanks to everyone, especially Emily Dalton, who said she will do it again next year (applause). She shared thank-you cards from judges.

Report of the Secretary: Mail: Catalogs, thank you from vendor, Bulldog club suggestions for judges.

Report of the Treasurer: Sandra shared a preliminary show report. See above.

Report of the Committees:

- Ring Practice: None currently. Anybody who wants practice should ask on the yahoo group. The mid-week club practice didn't work.
- Newsletter: Kudos to Tina for a great newsletter, thanks to Emily for the show photos.
- Website: nothing new.
- B-OB Show: The missing rally equipment was found, stored at a member's house who didn't remember that it was there. The show review will be at the August meeting. Irene has suggested buying a refrigerator for hospitality. **MSAC to buy a medium refrigerator and another ice chest (Sara/Emily).** Jill has lost and found, and has returned everything with identification.
- Agility Trial and Barn Hunt: Beverly didn't have a barn hunt judge until this morning due to lost communications. Two judges will share, plus learning judges. Problem with entry: An exhibitor entered the trial, her dog got hurt, she notified the secretary before closing, but her check was deposited instead of being shredded, causing bank fees. We agreed that this is a problem between the exhibitor and the secretary, and the club should not be involved. Discussion of: Clothing (\$40 for tie die hoodies, \$30 to members). Barn Hunt location at close end of field, for straw delivery, Friday-practice, Saturday-competition. Food worker vouchers, Chocolate bars, Judges' gifts (Tshirt, choc bar, mug Starbucks gift certificate). Vendors include Linda Lyman Pawssage Massage, video/photo; vendors are not charged, but are asked for donations for the worker raffle. Workers: Layout and canopies, Thursday at 9:30. Need help all weekend with many jobs, workers get vouchers. Friday set up at 9, then barn hunt, then agility match in the afternoon, take down Monday at 1:00. Recycle proceeds plus agility match profits will be donated to HumDog Spay Neuter program. Need to buy wading pool for cooling dogs. Discussion of food for hospitality.

Election of New Members: Beverly Brown of Eureka was elected to membership.

Unfinished Business:

- Woofstock: August 9. Application is sent in. Discussion of equipment needed and armbands/costs.
- Farm Store Pet Fair: Nothing out yet about this year.
- Hum Co Fair "Things To Do With Dogs Outside" August 19. Sara and Sandra will organize. Showing people different activities. Set up by 11.

New Business:

- MB-F gave us paper LCKC signs.
- Deb said that there were only three responses to the suggestion of a handling seminar, which is not enough. Will try again next spring before the show.

The regular meeting was adjourned at 8:45 p.m.
