## President's Corner

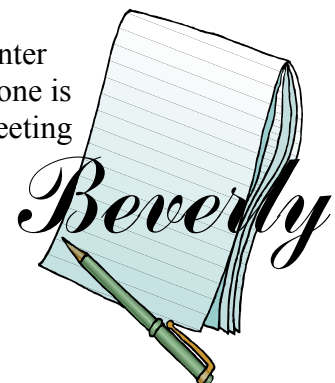

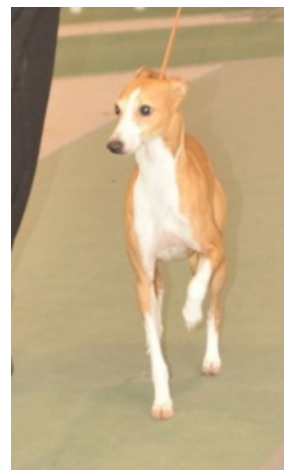


## From Kris and Bayard Smith :

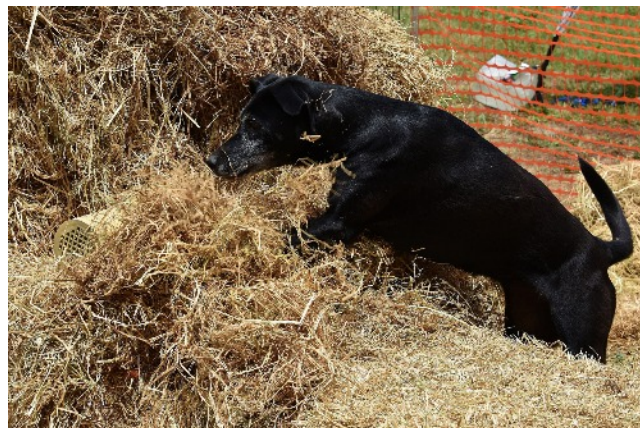
# Barn Hunt Practice

Everyone donated money to pay for the straw bales.

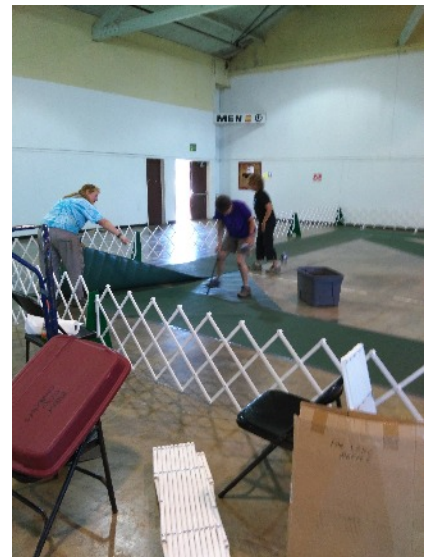
The bales were donated to LCKC to use as broken bales for the Barn Hunt.

Minutes of the Lost Coast Kennel Club  
June 16, 2015 at The Meadows, Eureka

**BOARD MEETING:** Called to order by President Beverly Morgan Lewis at 6:35 p.m.

Present: Emily Dalton, Mike Giusti, Sandra Gould, Beverly Morgan Lewis, Debra Loptien, Jill Otto, Kris Smith, Cathy Wright.

Minutes of the Last Meeting: Approved as published.

Report of the Treasurer: Sandra distributed reports for March and April, and reported that our federal and state taxes have been properly filed. Discussion about whether it would be better to do our donations after the shows when our yearly income is at its highest. Sandra will consult with the accountant to see if there is any advantage. She will not be present at the next meeting. She will order the dumpster and porta potties for the shows.

Unfinished Business:

- Riding Mower: The mower will be transferred at the show.
- Handling Seminar: Cancelled due to time constraint and lack of response.
- Trinity Co. Police Dog: There has been no follow up information yet about the Shasta Co. police dog regarding for what they need money. We will discuss more when we have more details. We don't want to donate for maintenance, but would consider for something specific. Discussion of parameters of the potential donation.

New Business

- Donation in memory of Irene Driver: Board will bring before the membership a suggestion to donate to the French Bulldog Charitable Fund.

The Board Meeting was adjourned at 6:55 p.m.

**REGULAR MEETING:** Called to order by President Beverly Morgan Lewis at 7:04 p.m.

Present: All of the above plus Michelle Dostal, Shirley Groom, Chris Irvin, Tina Moulton, Kathy Sobilo, Debbie Tull.

Minutes of the last meeting: Approved as published.

Report of the President:

- Beverly talked about a tribute to Irene Driver; the memorial is tomorrow; in lieu of flowers, donations are requested. **MSAC to donate \$500 to the French Bulldog Charitable Fund in memory of Irene Driver.**
- Pet Day at Fortuna Tractor Supply, May 30: Sandra and Jill attended for LCKC. There were some other organizations attending – HUMDog, Sequoia Humane, Miranda's Rescue with lots of animals. They have facilities available for use, including a field.
- Thanks to Bayard Smith for mowing the carnival field to prepare for the final mowing for obedience. The club will reimburse him for fuel if he sends a bill. Intelligent Agility has paid for the use of that field on Sundays.
- Parking reminder for the Meadows: Do Not park in front of the clubhouse, do park from the laundry room down the drive, or on the street.

Report of the Secretary: Mail: Catalogs, Woofstock app, and a CHF newsletter, which was distributed.

Report of the Treasurer: Sandra distributed reports; we have about \$32K in the bank. Taxes have been filed. Discussion of our tax status – the important thing is that we are NOT a charitable non-profit, so donations to the club are not tax deductible.

Report of the Committees:

**Ring Practice** Next Sunday is the last regular practice before the show, Cathy will do conformation, Shirley and her son will help. Additional obedience practices will be on June 18, 22, and 23. Some of our members attended a practice for Barn Hunt in Petrolia and had a great time.

**Newsletter:** Tina was congratulated on another nice issue.

**Website:** Everything is up to date. Links are up for the Agility Trials and Barn Hunt, and for the events next January.

**Yahoo List:** Up to date with new members. Tina encouraged members to cut their posts so we don't have to scroll through all the old posts to get to the new one.

**B-OB Show:** Emily led the discussion about the status of the show plans, including:

**Raffle:** Deb Loptien said it's going well, she will need a poster thanking donors, a white board was suggested. Discussion of raffle donors. Shirley needs someone to pick up donations in the southern part of our area.

Judging programs are out, we will have 75 catalogs.

**Grounds:** Everything is set, mowing, workers, parking. Vendors and workers get parking passes.

**Vendors:** Still waiting for Coffee and Tea, and Hot Dogs and Delites. No general vendor. Members will make bait and put them in snack sized bags for sale. Signs and ice chest at the main table.

**Press:** Tina has submitted information to various press outlets.

**Judge reimbursements:** Forms will be collected in a box on the main table.

**Hospitality:** No pre-orders this year, just a variety of food each day.

**CGC/TDI:** Beverly needs crutches (Kris will provide) and children for the testing.

**Filling in for Deb St Myers** who is bed ridden after neck surgery: Cathy will keep track of trophies, flowers will be handled by Chris, Jill will help get the flowers to the rings.

T-shirts: The tie dye short sleeved will be purple and black, the tie dye sweatshirts will be navy. Members will order after the show so they don't buy out the supply at the show. Discussion of which shirts are used for members (green) and for volunteers (grey).

Payment of food vendors: A suggestion was made to repay the vendors \$8 per ticket, no matter how much of the voucher was actually used. **MSAC with two abstentions to have the vendors write the amount spent on the voucher ticket and to total them for reimbursement.**

Obedience: Jane Patterson will volunteer for stewarding.

Sound system: Need to check with Sara as to status and set-up.

Raffle tickets for vendor sales: Vendors will give vouchers to be redeemed for raffle tickets to customers – 1 for each \$5 worth of merchandise bought.

Set up: Thursday, 9 a.m. 8:30 for hired people to drag out tables, etc.

**Agility Trial/Barn Hunt:** Beverly led the discussion, including:

We still need raffle items and workers.

Barn Hunt – the straw is ordered. Discussion of practice.

Ribbons are ordered.

Election of New Members: Lynn Mosher was reinstated to membership.

Unfinished Business:

- T-Shirts: See above in show report.
- Riding mower: Will be transferred at the show.
- Handling Seminar: Cancelled.
- Trinity County Police Dog: No donation at this time, we need more information.

New Business: Woofstock Application came, it will be August 8. Jill will submit the application. We need people at the booth, and will finalize at the next meeting. We will reimburse members who work for the cost of their wristbands.

Announcements: None

Additional business: Sandra was given the OK to get three good cash boxes.

The meeting was adjourned at 9:10 p.m.
