There will be a few additional weekday obedience-only practices at the fairgrounds as well. The dates for these are June 15, 18, 22 and 23 all at 3:00 pm.

We are also ramping up for the agility match and trials Friday – Monday, July 17th – 20th. Our Barn Hunt is the same weekend at the same place. There will be chance to get experience with Barn Hunt on Friday with two trials on Saturday and one on Sunday. 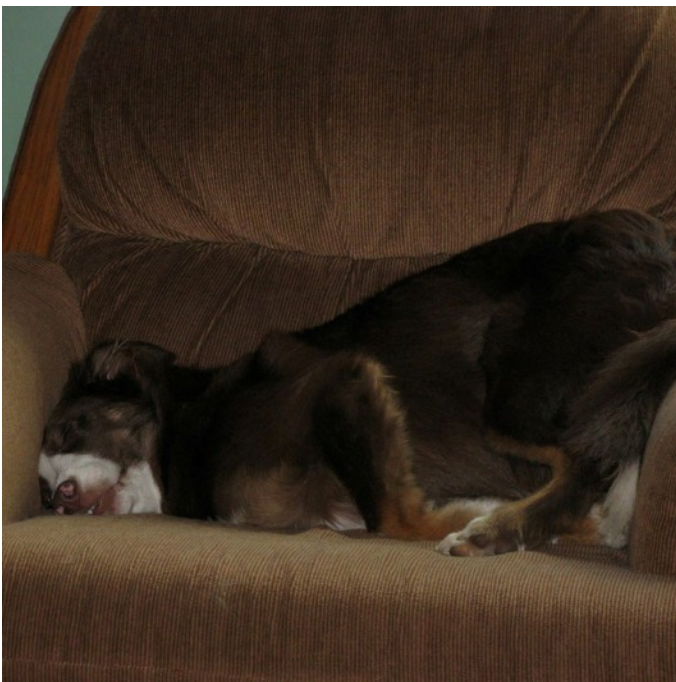
## From Tina Moulton :

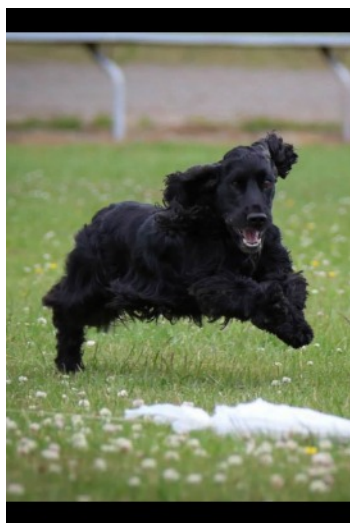

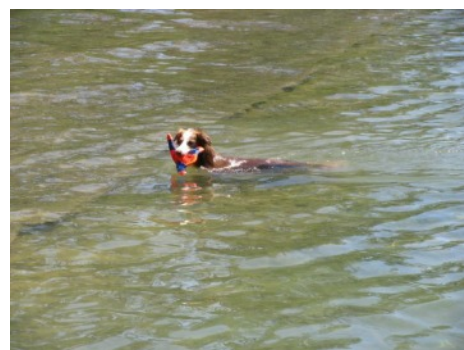

## Minutes of the Lost Coast Kennel Club May 19, 2015

**BOARD MEETING:** Called to order by President Beverly Morgan Lewis at 6:35 p.m.

Minutes of the Last Meeting: Approved as published.

Report of the Treasurer: Sandra distributed reports for March and April. Discussion about whether it would be better to do our donations after the shows when our yearly income is at its highest.

Unfinished Business:

- Riding Mower: The mower will go to Irene's daughter, Jennifer, for \$257.
- Adding Obedience/Rally dates: Beverly said Redwood Acres told her different dates and prices at different times. Finally had a meeting (with Pat Johnson) with the general manager, who promised to charge the original price for 2016 and book for January 21-24, 2016. Carolyn Wray is available to judge. Discussion of possibility of using provisional judges.
- Barn Hunt: The accompanying Barn Hunt can take place in the Pavillion.
- Handling Seminar: Beverly will contact Anita Gage to see if it is going to happen.
- Diabetic Signal Dog: Our donation has been presented.

New Business

- Fairgrounds Shed Rental: Sandra said it was paid in May.
- Trinity County Police Dog: From Irene – Discussion of donating money for expenses of a police dog; we are not comfortable donating money for an unspecified purpose, but would consider donating for something specific like a vest, etc. Sara will follow up. Discussion of how large a geographic area we want to include in our support of K9s.
- Pet Day at Fortuna Tractor Supply: Through Pat Johnson – “Purina Days Pet Fair” Sat, May 30, Sandra and Jill can go, Jill will follow through.

Report of the President: Beverly reported about Irene Driver's stroke and distributed a get well card.

Report of the Secretary: Various promotional mail and thank yous from our donations. Letter announcing the AKC Marketplace; we decided it is not appropriate for our club.

Report of the Treasurer: Sandra distributed reports, and said that we show having spent \$6,000 more than what has come in this year because our main income comes from the summer shows.

Report of the Committees:

**Ring Practice:** Cathy had two ring practices, mostly rally. They will be every week now until the show at the Fairgrounds.

**Newsletter:** Nothing new.

**Website:** Nothing new

**Yahoo List:** Up to date with new members.

**B-OB Show:** Emily led the discussion about the status of the show plans, including:

Grounds: ER has been paid; we need recycle boxes; Irene's granddaughters will be hired for parking; Sara will ask the rowing team for set-up and take-down help; mowing needs to be done by the Fairgrounds, then again by us.

MB-F: Need starting time and lunch break time (11:30 – 12:30), catalogs – 75, catalog color (same), breed requests.

Vendors: Coffee will be done by Loose Leaf Mobile Tea and Coffee stand, they will do judges coffee. Hop's BBQ can come, and Northtown Dogs and Delites. Still no general vendor; we can sell bait at the table. We are not charging food vendors for space. We received a warning about a freelance photographer who does ringside photos and markets them online. Discussion about what to do if she comes to our show – not likely this year.

Debbie Tull, as a vendor, suggested having incentive for people to visit vendors. Decision: For every \$5 spent at a vendor, you get 1 raffle ticket, signs should be up at vendors and raffle table.

Vendor tickets distributed for approval – suggestion to add space for exact amount spent.

Inquiry about having a conformation match before the show – not this year – we are maxed out.

Handling class is not in the premium list. We can post signs if we have it.

Catalog ads: None yet except for our BIS list.

Publicity: Tina and Deb working on posters. Tina will contact press. Jill will see about Piersons marquee sign, someone will need to check with Myrtle Ave Pet. Smiths will put up big wood signs. Posters will be distributed at ring practice.

Hospitality: All good.

Logistics: The judges all have plans now, we decided to cover rental car expense. Judges letters should have directions and room and expenses payment protocol. Emily will do welcome bags – chocolate bars, nuts, water.

Schedule: Rings 3 and 4 need to be done first to get ready for groups.

Trophies: Gift cards for Juniors – Cathy will contact Deb.

Obedience/Rally: Discussion of Stewards.

T-shirts: Not finding tie dye in other colors.

Raffle: Discussion of items and procedure. Approval of \$200 to buy big ticket items.

Set up: Thursday, 9 a.m. 8:30 for hired people to drag out tables, etc.

**Agility Trial/Barn Hunt:** Beverly led the discussion, including:

Motel: Red Lion Inn has a good pet fee, will put the event on their website.

Tina will do advance publicity.

Rowing club members available for set up and take down - \$10/hour?

Need Worker's Raffle person.

Election of New Members: David Lindberg of Eureka was elected to membership. Lynn Mosher's membership has lapsed, so she will have to reapply.
