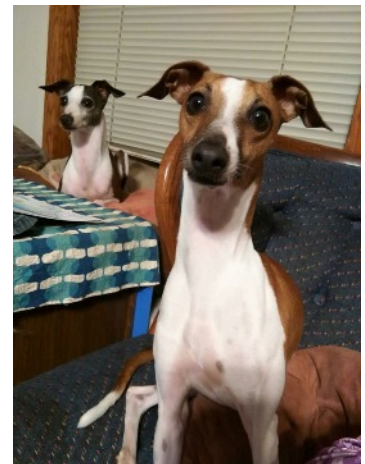
## From Beverly Morgan Lewis:
