
## From Tina Moulton:

Entries were up a little. Discussion of dates of other trials and how they may effect ours next year. Barn Hunt is not a money maker, but may draw entries for the whole weekend; also, we do it because we enjoy it. Match profit was close to \$1,000. MSAC to donate \$200 to the Ferndale High School Soccer program and \$500 to the HumDog Spay Neuter program. Suggestion to remove Quality Inn from list of hotels. Sara will call motels. Discussion of tie dye clothing no decisions. If the equipment recommendations are approved by the AKC, we will have to buy some new jumps. There will be an implementation period.

#### Unfinished Business:

- October Club dinner: October 14, Banana Hut, Eureka, 6 pm. MSAC for the club to pay for dinner, dessert, 1 guest, 1 non-alcoholic drink. 10% of profits from this night will go to breast cancer project.

MSAC to spent \$200 to buy a used 10x10 canopy, a small refrigerator, and some shelving from Chris Irvin's parents.
