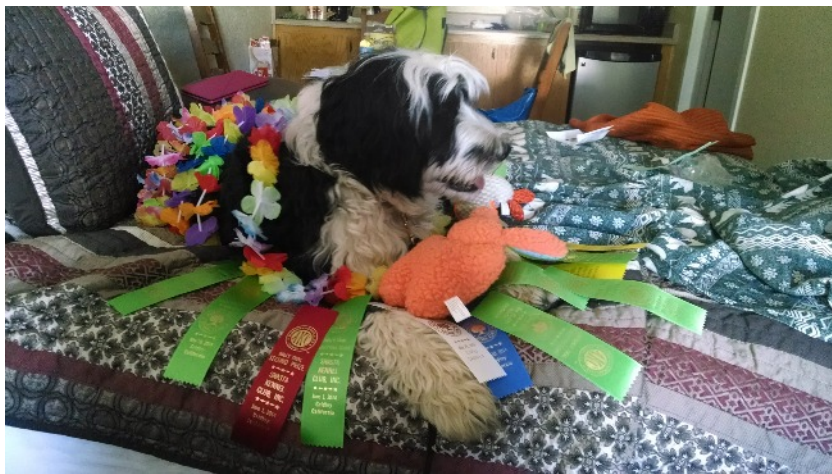
## **From MaryAnn Wik :**

MINUTES OF THE LOST COAST KENNEL CLUB  
August 19, 2014, The Meadows, Eureka

BOARD MEETING: Called to order by President Beverly Morgan Lewis at 6:37 p.m.

Present: Sara Borok, Emily Dalton, Sandra Gould, Mike Giusti, Beverly Morgan Lewis, Tina Moulton, Jill Otto, Kris Smith, Deb St Myers and guest Kathy Sobilo.

Minutes of the Last Meeting: MSAC to accept as published.

Report of the Treasurer: Sandra distributed and explained a Treasurer's Report for July and a report on the show. Show income was about \$7338. There may be a few more charges on the debit card. Discussion on where to put the clothing expenses.

Unfinished business: none

New Business:

- The Meadows has a new property manager. Sandra assumes that we will still be able to meet here.
- Discussion of how many more events we can have per year. We would like to have an obedience trial and barn hunt, maybe February, maybe Redwood Acres. Sara and Deb will investigate. Discussion of what super/secretary to use.

The Board meeting was adjourned at 7:02 p.m.

REGULAR MEETING: Called to order by President Beverly Morgan Lewis at 7:02 p.m.

Present: All of the above plus: Susan Dean and Chris Irvin.

Minutes of the Last Meeting: MSAC to accept as published.

Report of the President: Big thanks to everyone who helped at the agility trial – exhibitors, vendors, everybody was happy. Also thanks to those who helped at Woofstock.

Report of the Secretary: Mail: CHF renewal, **MSAC to renew CHF** membership - treasurer will send; photo album of the show from the Cooks; donation request from Sequoia Animal Shelter; catalogs; donation from agility exhibitor; AKC agility trial reports.

Report of the Treasurer: Sandra distributed a monthly report and a show report. She shared preliminary information on the agility trial, agility match, and checks from the agility secretary. Beverly said she ordered multiple Championship ribbons because we needed 2 more, so now we have them for next year.

Report of the Committees:

- Ring Practice: None currently. Anybody who wants practice should ask on the yahoo group. Perhaps some in September in preparation for the Pleasonton shows.
- Newsletter: "Late but Great", thanks to Emily for the wonderful agility trial photos.
- Website: Tina has updated it with links to all results. She is now administering the Yahoo group.
- B-OB Show Wrap up: Show chair Emily Dalton reported: There were lots of compliments on the raffle; Cindy doesn't want to do it again, so we need someone to step up. Vendors – there weren't many locals, we need to work on that, and more food vendors, and we need a new vendor chair. Rally/Obedience – lots of new exhibitors, judges commented on the beginner level of competition, but that's OK – we offer a place for people to get started. Trophies were very nice this year, local art; everybody liked the chocolate bars, but we need more dark next year. Hospitality – judges liked picking their food ahead; Chris I's parents are downsizing, so we might be able to buy a refrigerator and shelving from them; having the judges turn in receipts for motels and food worked well; next year Emily can do judge logistics. There were no complaints about the judges. EMT, Safely, all OK. The sound system needed figuring out. Jill has returned everything in the lost and found, and has gotten thank-yous and postage in return. Emily will put together job descriptions and put them in the Yahoo Group files. Sara said we might have a buyer for our mower if we want to sell it. We didn't use it, but hired the show mowing done, which worked well. We will talk about it next month. Sara will ask on the Yahoo Group if members have opinions. We need to get the sheep off the obedience field earlier in the year. Lure coursing was very popular, would be good to start before BIS. We need to raise RV and parking fees to reflect raise in fairground costs. Should raise entry fees, too. Need to have recycle bins – Eel River Disposal should provide them. We may need to be thinking about more/new grounds people. Publicity – need more advertising, more control of posters, need to buy a new banner for the Ferndale intersection. Financial note: expense for bought raffle prizes is not in the show report.
- Agility Trial and Barn Hunt: Review in September. The AKC Agility Advisory Committee has made rule changes on equipment, so we might have to replace our jumps. Beverly will put up their recommendations on the Yahoo Group.

Election of New Members: Kathryn Sobilo of Eureka was elected to membership.

Unfinished Business:

- Farm Store Pet Fair: Sara will take the lead. Need to put together a basket. We have 2 canopies, one is broken and needs to be thrown away - Tina will salvage for parts and recycle. We could buy a used canopy from Chris's parents if they want to sell it.
- October Club dinner: Be ready to discuss a date and place next meeting.
- Fair Day: The "Things to do with your Dog Outside" event was not well attended by spectators. There were 15 dogs and 3 spectators. It was difficult working with the fair people. Not worth doing it again. Maybe something for the fair at Redwood Acres?

New Business:

- Deb is looking into more options for tie dyed shirts.
- The covers for our big show canopies are wearing out. They are cumbersome and heavy – we should look into replacing them with EZ up 10 x 20 canopies. Will discuss next time.

The regular meeting was adjourned at 8:50 p.m.
